The term "heirs," or other words of inheritance, shall not be necessary to create or convey an estate in fee simple; and any conveyance of any real estate hereafter executed shall pass all the estate of the grantor, unless the intent to pass a less estate shall appear by express terms, or be necessarily implied in the terms of the grant. A covenant in a deed to a railroad company, by which the grantor agrees to build a fence along the railroad, "or not hold such railroad responsible for any damage done to stock belonging to us." without any mention of assigns, is personal to the grantors, binding them only...
